FIRST AID

GENERAL INFORMATION

REJUVENATE is formulated to prevent sand traps from failing and to revive and restore distressed sand traps. **REJUVENATE** will improve water drainage, help prevent wash-out and erosion, and allow the sand to regain its original color. **REJUVENATE** will enhance the overall appearance and function of your sand traps without the need for reconstruction and reduce the costs of labor and maintenance.

DIRECTIONS FOR USE

Apply 200 ounces / 1000 square feet of **REJUVENATE** directly onto the sand of a sand bunker. Do NOT allow **REJUVENATE** to contact turf. Water in immediately after application.

Apply this product with spray equipment containing parts made of PVC, plastic or fiberglass.

REJUVENATE is NOT to be tank mixed or applied with any other products.

STORAGE AND DISPOSAL

Storage: Store in a cool, dry place. Store in original container only. Do not add anything to the container. Keep container tightly sealed when not in use. Do not store near fire, flame or other potential sources of ignition. Do not contaminate water, food or feed by storage or disposal of this product. For optimal storage, store between 40 and 90 F.

Disposal: Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal if allowed by law.
